Saturday, April 12, 2014: 7:00 a.m. – 3:00 p.m.



## 2013 Curbside Recycling Rate Below State Goal

The 2013 residential/commercial recycling program achieved a 26.1% rate, which is below Pennsylvania's recycling goal of 35%. Statistics for 2013 are as follows:

- •3,300.8 tons of waste generated
  - -2,438.9 tons refuse sent to County incinerator
  - -602.58 tons residential recycling
  - -259.36 tons commercial recycling

# Tree Trimming Along Streets and Roads

The Township Maintenance
Department will continue
trimming trees, shrubs, bushes,
and other similar vegetation along
the Township streets and roads
during the spring months.
Trimming will occur within the
Township's road right-of-ways and
will not exceed a height of 14 feet.

#### **Complaints**

Residents who wish to file a complaint for noncriminal violations must follow several guidelines. The complaints must be in writing and contain contact information; anonymous complaints <u>WILL NOT</u> be accepted. All complaints <u>remain confidential</u>. Complaint forms can be obtained at the Township office or on the Township's website and can be filed in person, by mail, fax, or email.

#### **York County Special Needs Registry**

The York County Special Needs Registry is a free, voluntary, and confidential program, open to all county residents to provide assistance to those with special needs in the event of an emergency. It is designed to help identify those who have no reliable source of assistance in the event of an evacuation or other emergency.

Those who would benefit the most include Individuals with:

- ♦ Wheelchairs, walkers, canes, etc.
- ♦ Service animals
- **♦** Immobility
- ♦ No family, friends in the area, or means of transportation
- ♦ Mental disabilities
- ♦ Physical disabilities
- ♦ Special needs

State law requires each township, borough, and city to maintain information about special needs people in their jurisdiction. During the February ice storm and subsequent power outage, it became apparent the information the township has on file needs updating.

The County Special Needs Registry is a tool provided to the municipalities to make this task easier. The program was developed by the York County Human Services Department in conjunction with the York County Office of Emergency Management.

Residents have the option to participate in the Registry by filling out a one-page form. Information from each form is then entered into a computerized mapping system.

The collected information can be used by fire, police, ambulance, and emergency management officials to ensure resident safety in all types of emergencies and disasters – including long term power-outages, snow, ice, floods, fires, chemical spills, and police incidents.

You can register by calling the Township Office at 235-3011 and requesting a form be mailed to you, by downloading the form from York County's website and returning it to the township office (http://yorkcountypa.gov/images/pdf/ECRIN%20Form%20October%202013.pdf), or by calling the Township Office and giving them the required information.

## Planning a Spring Building or Home Improvement Project?

Following is a partial list of required permits. While the descriptions cover the most typical reasons for a permit, the list is not all-inclusive. If you have questions or want to verify if you need a permit, please call Megan Matthews at 235-3011 (ext. 103).

- Driveway Permits: Permits are required for all new driveways, repaving of existing, widening or any other improvements completed on existing driveways.
- Well Permits: Permits are required for the drilling of new well in Shrewsbury Township. All wells are required to be grouted.
- Swimming Pools: All pools capable of containing more than 24 inches of water require a building permit
  and zoning permit. This is part of the building code adopted by the Commonwealth of Pennsylvania.
  Pools must meet the setback requirements of the Zoning Ordinance as well as all requirements of the
  building code. This means fencing may be required and in some instances pool alarms must be installed.
- Zoning Permits: Shrewsbury Township's Zoning Ordinance requires zoning permits for all accessory structures in excess of 100 square feet. This will ensure accessory structures such as sheds, and fences are placed according to the setbacks and regulations of the Zoning Ordinance. Please note that while zoning permits are not required for smaller structures, all setback and related zoning regulations must be met.
- Interior Renovations: Cosmetic renovations such as carpet, painting, and replacing existing windows/doors do not require permits. If any moving, relocating or installation of new plumbing, mechanical, and electric lines occur please be sure to pick up a permit.




## **April is Earth Month – our collective responsibility**

All of the 29.4 sq. miles, or 18,606 acres of land comprising Shrewsbury Township, consists of 4 public water supply watersheds serving the residents of York County or metropolitan Baltimore. Every drop of precipitation that falls in Shrewsbury Township, therefore, could end up in someone's drinking cup.

Officially, and on your behalf, Shrewsbury Township has initiated the following practices to protect our watersheds/water supplies:

- Require stream buffers.
- Protect wetlands, springs and seeps.
- Require erosion and sedimentation controls.
- Protect woodlands on developing sites.
- Restrict major development to within the Township's growth boundaries.
- Require stormwater management including infiltration of roof runoff.
- Require septic system maintenance.
- Street sweeping.
- Preserve open space/agricultural land.



- Don't wash vehicles on paved surfaces and permit the dirty water to flow into a storm sewer, which then flows to a local stream. Wash vehicles on an unpaved or impervious surface.
- Don't over-fertilize your lawn.
- Eliminate or reduce the use of pesticides.
- Clean up pet litter regularly.
- Plant mature trees and shrubs.
- Install rain gardens.
- Keep your property neat and orderly and free of clutter.

The Chesapeake Bay has been known as the most productive estuary in the world. The Bay is the sink or the final destination of all of the pollutants, which have resulted in the Bay's decline. Acting as caring residents, and by being responsible property owners, we can join the effort to restore the Bay.

#### **Celebrate Earth Day with Free Tire Disposal**

To help eliminate illegal dumping of tires and educate the public about proper tire management, the York County Solid Waste Authority (Authority) is offering free tire disposal at the York County Resource Recovery Center. <u>Preregistration is required</u> and will be accepted during business hours between now and April 23, 2014.

Residents may call Jen Cristofoletti at the Solid Waste Authority to pre-register at 717-845-1066 from 8AM to 5PM Monday through Friday **starting March 3**. Registrants will receive a dashboard placard for free one-time disposal of up to 10 tires. Tires must be off the rim and cannot exceed 32" in diameter. Tires must not be excessively dirty or full of water. This program is limited to one placard per household. The program coincides with Earth Day celebrations and is open to York County residents only. Businesses are not eligible to participate. **Registration ends** at close of business on April 23, 2014. Tire delivery dates will be scheduled on a first-come, first served basis.

This program is a result of the Authority's participation in and support of Keep York Beautiful and its efforts to prevent and eliminate illegal dumping. Dave Vollero, Authority Executive Director, notes that, "Residents can and should place old tires out with their regular garbage. This special tire acceptance program is being held to raise awareness that tires should be properly disposed of as household waste and to help prevent illegal dumping of tires." Tires collected at the curb with regular garbage must be off the rim and may not exceed 32" in diameter. Residents should call their waste hauler for specifics on how many tires can be placed out with each pick-up.
