

Snow Information

<u>Mailbox Damage</u>

The Township does not prohibit property owners from placing mailboxes within the limits of the legal right of way, as it is recognized that the post office has certain placement requirements regarding the location of mailboxes. However, since these mailboxes are not placed under permit regulations, they are technically deemed to be encroachments, which are placed and remain at the risk of the property owner. Therefore, Shrewsbury Township is not liable for damages to mailboxes, fencing, shrubbery, trees, etc., caused by snow removal or other maintenance operations where the same are located within the limits of the legal right of way. (Ref: Code of the Township of Shrewsbury, Chapter 21, Part 2, §21.201).

The term for Board of Supervisors Susan Fox and Cynthia DeLeone ends December 31, 2015. Therefore, there will be two (2) Board seats on the May Municipal Primary ballot and the November Municipal Election ballot. Important dates for any person interested in running for these positions are below:

- **February 17**th First day to circulate nomination petitions for the PRIMARY election.
- March 10th Last day to circulate and file nomination petitions.
- May 19th Municipal Primary Election



During the winter months the Township Maintenance Department will be trimming trees, shrubs, bushes, and other similar vegetation along Township



Board Actions (October – December 2014)

- Authorized the sale of a Township owned (1987) grader.
- Conditionally approved Final Subdivision Plan of John & Annie Esh (Valley Road, Glen Rock), along with approval of several waiver requests and DEP Sewage Planning Waiver.
- Conditionally approved Preliminary/Final Subdivision Plan of Tolna Road Venture (Tolna & Mt. Airy Road).
- Approved Resolution No. 2014-19, which adopts a maintenance department safety manual.
- Approved Resolution No. 2014-20, which sets the 2015 real estate & fire tax rates.
- Approved Ordinance No. 2014-06, which establishes a fire hydrant tax for all properties located within 780 feet of a fire hydrant.
- Approved Ordinance No. 2014-07 & 2014-08, which authorizes the Township to continue participation in PSATS' Health Insurance Cooperative & Unemployment Compensation Group Trusts.

Recycling Audit

The Township's 3rd quarter 2014 recycling rate is 21.8%. This rate remains well below Pennsylvania's goal of a 35% recycling rate.

During the period of August – October 2014, the Township conducted 4-week recycling audits of 433 households. Of the total households audited, over the 4-week periods, 33 households did not recycle, 51 households recycled 1 week, 87 households recycled 2 week, 99 households recycled 3 weeks, and 163 households recycled 4 weeks. Shrewsbury Township mandates that ALL properties within the Township recycle. Failure to recycle could result in a fine up to \$1,000, including court costs.


Electronics Recycling

Electronics for recycling can be dropped off at the Township office (11505 Susquehanna Trail South, Glen Rock) Monday – Thursday from 8:00 a.m. – 3:30 p.m. and Friday from 8:00 a.m. – 11:30 a.m. Please note that you must be a Township resident or business to participate in this program and photo identification must be provided.




2015 Budget

On December 4, 2014, the Board of Supervisors approved the 2015 budget with revenues totaling \$2,315,230; expenditures totaling \$2,480,153, and a projected December 31, 2015 fund balance of \$2,489,555.



The general fund real estate tax rate will remain unchanged at 0.074 mill, which equates to \$14.80 on a home assessed at \$200,000. The budget does include an increase in the Special Fire Tax to 0.34 mill, up from 0.25 mill, which will result in an increase of \$18 per year on a home assessed at \$200,000 (from \$50 to \$68). Proceeds from the fire tax are distributed to the three (3) volunteer fire companies that serve Shrewsbury Township, including Shrewsbury, Glen Rock, and Rose (New Freedom) Fire Companies. The 2014 tax distribution to each of these fire departments was \$47,465 (less any workers' compensation premiums). The 2015 distribution to each fire company is expected to increase approximately \$15,000.

New for 2015 will be a new tax for all properties located within 780 feet of a fire hydrant. The fire hydrants are not owned by the Township, but are owned by either The York Water Company or the Glen Rock Water Company. Each water company bills the Township for rental of the fire hydrants, which is approximately \$18,500 per year. In past years, the Township has paid this charge out of the general fund, in which 100% of properties pay into, while only 28% of properties are within 780 feet of a fire hydrant. There are approximately 810 properties affected by the new tax, which is set at 0.12 mill of the assessed value. On an average assessment of \$203,502, the annual fire hydrant tax will be \$24.42.

PAPER, PAPERBOARD & CARDBOARD: Recycle Any Size. Any Quantity.

Please break down boxes as flat as possible and put them out next to your recycle bin on your pick-up day.

- Cardboard boxes
- Clean pizza boxes
- Food boxes (i.e. cereal & gelatin boxes)
- EMPTY paper towel and toilet paper rolls
- Paperboard packaging (i.e. tissue boxes)
- Office paper (any color)

- Newspapers and inserts
- Magazines, catalogs, and brochures
- Envelopes & junk mail
- Paper bags
- Phone books & other soft cover books
- Paperboard food and drink cartons
- ✓ Remove all packaging (Styrofoam, peanuts, plastic bubble wrap, plastic liners, etc.)
- ✓ Flatten ALL boxes
- ✓ Bundle all cardboard that does not fit into the recycling bin
- ✓ Cover loose paper with heavier items to prevent it from blowing away
- ✓ If the weather forecast calls for high winds or wet weather, if possible, keep your paper recyclables until the next week. Wet paper products are difficult to process.

- · Drinking glasses

- Plastic tableware (knives, forks, spoons)

- Wet papers or cardboard
- Plastic food wrappers

As of January 24, 2013, *by law* Penn Waste is not allowed to collect your electronic waste.
