**INSPECTION INFORMATION**

During the inspection for Real Estate Transfer the property owners and/or agents of Real Estate Transfer must have septic tanks fully pumped out by a **licensed pumper who is registered with Shrewsbury Township**. Full access to the top of the septic tank must be made so that the large 20" diameter concrete lid can be opened for proper pumping and inspection of each tank. This requires digging down to the top of the tank ahead of the scheduled inspection. I understand the above information and will make sure that the septic tank(s) are fully accessible as described above just prior to the time of pump out and inspection so as to facilitate an expedient inspection.
